

MIX-N-FIX XL

MIX-N-FIX XL is a waterproof, thick/thin bed material made from cement, the finest aggregates and the best quality additives. It is specifically formulated to bond a variety of tiles onto rigid substrates. The use of Mix-n-Fix XL would ensure an excellent bonding for your tiling or cladding jobs.

ADVANTAGES



Soaking of tiles in water is not essentially needed.

Wetting of the surface to be tiled is not necessary as Mix-n-Fix XL works perfectly on clean & dry surfaces. However, washing a surface to clean & remove loose particles, etc is recommended ¹/₂ hour prior to the fixing. Curing is not required as Mix-n-Fix XL is self-curing. Hacking or roughening of the surface to be tiled is not necessary.

Tiles direct from the box, can be fixed on thet desired surface, minimising possible breakage & labour cost on soaking.



Mix-n-Fix XL waterproofs the entire surface it is applied upon.

METHOD OF USE

Mix-n-Fix XL can be used on both walls and floors, in interior and exterior applications. Mix-n-Fix XL is highly recommended for the thick/thin bed-fixing of a variety of tiles. Mix-n-Fix XL can be used to fix tiles on to concrete, cement renders/ screeds and rendered brickwork. Mix-n-Fix XL can also be used to fix dense, vitreous ceramic tiles, marbles, granites, etc. by adding ZORISCOTT* in the mixing water. 1 part ZORISCOTT & 4 parts clean water should be mixed, and this mixed solution should be used with Mix-n-Fix XL for fixing dense tiles.

APPLICATION INSTRUCTIONS

Spread the creamy mortar onto the surface using a notched trowel to a thickness of 2-3 mm. Tiles must be coated with the creamy mortar (like coating butter on bread) and fixed on the mortar-applied surface. The final bed thickness for wall tiles is minimum 2 mm whilst for floor-tiling, a minimum bed thickness of 3 mm is recommended. At any one time, do not spread more than one sq. metre of mortar on the surface. Tiles must be pressed firmly into position before the mortar skins. Make sure that all the tiles are well-bedded and there are no voids under the tiles. Once the tiles have been fixed, they must not be disturbed for 24 hours.



SURFACE PREPARATION

All surfaces should be structurally sound, clean, dry and free from oil, grease or any other loose materials. Newly rendered/screeded surfaces should be allowed to cure for at least 10-15 days. New concrete must be cured for 4 weeks. Steel trowel well finished concrete must be mechanically abraded prior to tiling. Porous surfaces should be primed/sealed using a cement fortifier (ZORISCOTT)*.

MIXING

Add Mix-n-Fix XL to a bucket containing clean water, mixing uniformly/constantly to achieve the required thick, creamy consistency. The mixing ratio is 25 kg of Mix-n-Fix XL approximately to 5.5-6.5 litres of water. Allow the mixed creamy paste to stand for 5-10 minutes, remix and it is ready for use.

GROUTING

Grout joints of 1-5 mm width can be grouted with COLOR TILEWALLA. For larger grouts that are 5-12 mm wide, use a special bonding agent ZORISCOTT^{*} for increased water resistance & flexibility.

CLEAN-UP

Remove any excess mortar from the face of the tile using a damp cloth, while the mortar is still in the wet condition. Tools & equipment should be cleaned with water before the mortar dries.

PRECAUTIONS

Do not allow the applied material to skin prior to tiling. In case of skin formation, remove the same and dispose, then re-apply a fresh material. ZORISCOTT should be used with Mix-n-Fix XL when tiling areas where ponded water and continual immersion occurs i.e. swimming pools, spas, etc.

5kg, 20kg & 30 kg bag.

SHELF LIFE

Upto 12 months in unopened bags, when stored in cool, dry conditions.
