APPLICATION INSTRUCTIONS

- Remove dirt, dust, loose particles, oil & grease from the joints & cracks using a wire brush, with plenty of water to wash • down the said particles etc., and to moisten the surface as well.
- Widen small narrow cracks & joints and make them U shaped with the increased depth to ensure deeper penetration, proper filling and bonding of KRACKSEAL-XL

AREA OF USAGE

- Filling and sealing of cracks and holes in roofs, terraces, water tanks etc. for stopping leakage & seepage completely.
- Gaps between masonry/concrete structures and aluminium windows, doors, wooden door frames and windows.
- Joints in cast iron, cement pipes.
- Filling the gaps/holes in AC sheets for 'J' bolt.
- Permanent & firm filling of the cavities behind wash basins, sinks, bath tubs.
- Sealing and plugging of structural joints.
- Repairing damaged and decaying structures.
- Plugging the gaps and cavities in between precast structures.
- Leak-proof filling of precast pipe joints.

DIRECTIONS FOR USE

Use wet spatula, putty knife to fill the gap, joints & cracks.

Care should be taken to ensure that no voids, cavities or air bubbles are formed while applying/filling. Level the surface with a wet spatula/putty knife and allow drying/curing for a period of 24-72 hours. In case treated cracks/joints/gaps show any shrinkage after the drying, the same should be topped up to the desired level and allowed it to dry.

PRECAUTION

Application not recommended while raining or when rain is forecasted. Do not use below waterline application. Store away from extreme heat or cold

CLEANING OF TOOLS & HANDS

Hands & tools can be cleaned conveniently with the help of soap & water.

PACKAGING

KRACKSEAL-XL is available in 500 grams, 1 kg & 5 kg packs.

SHELF LIFE

At least 12 months from the date of manufacture in the original sealed condition.

STORAGE

Low or high temperature storage should be avoided and the adhesives should preferably be stored within the temperature range of $+5^{\circ}$ C up to $+35^{\circ}$ C.
